Policy and Procedure Report

I attended the Admin meeting and incorporated the SacFNA Guidelines with the changes that we reviewed with the GSRs in the October ASC. The Guidelines are presented today for final GSR approval. A hard copy is provided for each table for your reference, pending your final approval at the November 9, ASC meeting.

Note: The official "approved" Guidelines will be posted to the SacFNA Website after our November 9, 2016 meeting.

Summary of What's Changed?

Changes in the GUIDELINES include the following:

- Section Four, Article III added more detail about area member requirements.
- Section Five, Article II added voting card colors for clarity.
- Section Five, Item F (NEW), Article III clarified voting process if no opposition.
- Section Six, Article II changed "Business" to "Proposals"
- Section Six, Article III (NEW) Added policies for Activities sponsored by groups, single point of accountability, & role of the Activities Liaison.
- Section Seven, Article I, and Article II added new responsibilities to various Admin Officers
 duties (see highlights) for P.O. Box, Storage, publishing records of donations including H&I,
 learning QuickBooks; and tracking literature orders. Removed Group Orientation responsibility
 from Policy and Procedures, and clarified Jr. RCM is responsible for this duty. Also, clarified
 difference between GSR "Service Packet" used at group orientation vs.Group "Starter Pack"
 purchased and provided by ASC for new groups.
- Section Seven, Article III clarified audit oversight by two admin members.
- Section Eight, Article III, Item D explained what simple majority means. Item D, increased ineligibility from six to 12 months.
- Section Ten, Article I, clarified process for approving and posting flyers; Article II, removed duplicated Item.
- Appendix C Added Treasure to provide group reports, including H&I donations. in January & June.

Changes in the SERVICE STRUCTURE include the following:

- Revised Activities Liaison role & responsibilities to assist Groups, (who will now take the lead and nominate a single point of accountability), to develop and implement approved activities.
- Activities Liaison will ensure groups understand and perform the required coordination tasks, including preparing and proposing a budget on the approved ASC activity proposal for, necessary to implement an approved activity. Added Reference to Guidelines

H&I Guidelines for a Facility Coordinator:

Facility Coordinator: Suggested clean time requirement a minimum of one year or whatever is required by the facility, plus six months prior participation as an H&I volunteer. Responsibilities of the position include:

- Serves as a mentor for any new volunteers; informs volunteers of the procedures for conducting the meeting and ensures that the meetings are conducted in accordance with the policies of the Working Group and the rules of the facility.
- Acts as a liaison between the Working Group and the facility.
- Ensures a regular schedule of volunteers for each meeting in the facility.

- Maintains current volunteer contact information and ensures that the Working Group Secretary is given that information for the Working Group records.
- Keeps all volunteers informed of any facility rule changes.
- Attends the Working Group meeting and presents a report. If unable to attend the meeting, the Coordinator will provide a report to the Task Leader or Co-Task Leader.
- Notifies the facility and/or volunteers in the event of a meeting cancellation.
- Finds a replacement or assumes the responsibilities for a volunteer unable to fill his/her commitment.
- Coordinates and maintains proper clearances as required by the facility for all volunteers.
- Establishes a meeting format (e.g. speaker meeting, Q&A, literature study).
- Accepts responsibility for the conduct of volunteers attending the meeting.
- Reports to Task Leader all incidents of inappropriate behavior of volunteers from the facilities.
- Ensures that current information is on file with the Secretary including:
 - 1. Facility volunteer list containing contact numbers and clean dates
 - 2. How volunteers are scheduled
 - 3. Facility contact personnel and numbers
 - 4. Facility applications if required
 - 5. Facility rules and regulations that apply to H&I volunteers and any other information pertinent to the facility

The H&I Task Group is in need of volunteers to help with becoming Coordinators the facilities listed above. The current Coordinators have been doing the job for years and would like, not to abandon the facility, but to literally take a break from being the Coordinator. We welcome any recovering addicts who want to be of service to Hospitals and Institutions. You can come and visit our meeting on the third Monday of each month in room 12 in this same location. H&I truly carries out our primary purpose and is a great way to give back. Our next meeting is November 21st, 2016.

We also are in need of an H&I Co-Task Leader.

H&I Guidelines for a Co-Task Leader:

Co-Task Leader: Suggested clean time requirement of two years. Responsibilities of the position include:

- Assumes the duties of Task Leader in the Task Leader's absence.
- If the office of Task Leader should become vacant, the Co-Task Leader assumes the duties until a Task Leader is elected or appointed according to the SacFNA-ASC Guidelines.
- Works closely with the Task Leader to become familiar with all aspects of the Task Leader's responsibilities.
- Supports facility coordinators efforts to recruit volunteers.
- Finds appropriate placement for new volunteers wishing to do H & I service.
- Serves as temporary facility coordinator in the event of a vacated position.

The Sacramento Mail Jail Coordinator was notified that the Jail will now use a Personnel Driver's License or California ID as the means for access and all issued ID will be collected. The Coordinator will contact the Jail and verify the letter is real. Only one new applicant received the letter that we know of.

I have placed the "Books for Crooks Proposed Budget" on a separate sheet with last year's Actuals. We are looking at different venues that have better parking than the Church at 26th and K Street.

The Task Group will also be doing an H&I Guideline Review and will ask the ASC Body for Approval when they are finished.

Also, Since PR is not using the Schedules that were ordered for them, I ask that we decrease the number of ordered Schedules down to 4200 to cut the costs and we limit the number a Group gets to save some money for the body of the ASC. Good Evening Area!

I was unable to attend the RSC in Fairfield last month, but our wonderful Jr. RCM La Fonda went down there and represented SacFNA for us. I will share with you what was in the minutes at the RSC.

The Fellowship Services Team (FST) would love to put together an NA101 hosted in any of our areas. What is NA101 you ask? NA101 is an all-day event, hosted by our area and put on by the region, with the region covering all costs, including facility, food, insurance, etc. All they ask is that the area provides a Pot Luck lunch and has volunteers to assist with hosting the event: set-up, clean-up, running errands, coffee, etc. They will have FST members, Regional Pool Members and even RCMS assist in putting on interactive workshops on topics of the Area Service Committee's (ASC) choice. Here are the topics available plus if they don't have a topic we want they will create a workshop of our area's needs.

NCRSC WORKSHOP MENU

Building Strong Home Groups: this workshop is meant to help NA members strengthen their home groups

Collaboration: collaboration is working together to achieve a common goal. We discuss and understand collaboration as an action principle and an integral part of our service system

Communication: our service structure depends on the integrity and effectiveness of our communications

Consensus Based Decision Making (CBDM): workshop shows a cooperative process for making decisions in which everyone consents to the decisions of the group

Disruptive Behavior/Atmosphere of Recovery: workshop is meant to help groups fulfill the responsibility of welcoming members without allowing an individual to threaten the safety of those attending a meeting

Environmental Scanning: look at two types of scanning, internal and external

Fund Flow in Na: how our money is used and how we can help

Group Conscience: this session provides opportunities to discuss principles of group conscience and delegation as they apply to decision-making and accountability for all NA services

H&I Fire Camps Presentation: bringing our message of hope and promise of freedom to inmate fire-fighting crews

H&I Sponsorship Behind the Walls: reviewing guidelines and generating support

H&I Training Guide: educating and reviewing the training needed to do H&I meetings

Interacting with the Public and Representing NA at PR Booths: (description in title)

Invest in Our Vision: review of IP No. 24 Money Matters, Self-Support in NA and IP No. 28 Funding NA Services

Leadership: roles, qualities, and practice of leadership in NA

NA Helplines: Carrying the message, one call at a time: session provides opportunities to discuss underlying PR principles with our helpline efforts. In small groups participants will discuss how to respond to various types of calls and present skits on various scenarios

Newcomer Orientation: Training for Future Panelists: workshop provides training and materials for holding Newcomer Orientations. It covers topics such as religion vs. spirituality, sponsorship, sharing in NA meetings, etc. Participants will prepare to serve on panels
