We decided at Admin that it was time for a refresher on the guidelines for submitting money and receipts to the ASC. Please review:

1. There will be no cash accepted for anything other than coffee or 7th tradition donations at the ASC. This is for the protection of the Treasurer, so please allow for the cost of a money order when your groups are deciding how much will be donated to H&I or ASC each month.
