Service Structure

As communication with American River Area regarding the best way forward for H & I, phonelines, and schedule continues, I wondered if it might be helpful to formalize the features of our service structure as it currently exists. We have resisted establishing standing subcommittees and have instead embraced aspects of the flexible service structure outlined in the new *Public Relations Handbook* (available at http://www.na.org/handbooks/PRHB_Final_24Oct06.pdf). This is a new way of doing business and other Areas in Northern California and elsewhere are also grappling with how to adapt or create structures that are most effective and efficient and carrying out our goals.

I've recently been in touch with some folks in Greater San Jose where they have a service structure working group tasked with proposing and rolling out changes to their already-established subcommittee structure. The group's co-chair shared a graphic overview of their concept for implementing a flexible service structure with me. I have adapted it as a starting point for conversations about our own service structure. I'd like to propose that we spend sometime discussing this in open forum tonight and in our home groups in the coming month. Once we've had time to discuss, reflect, and refine a model, perhaps we can come to a shared understanding of what our flexible service structure should look like going forward.

Good evening everyone, first of all I would like to thank the people who helped me get the orders out last ASC. Due to the large number of orders, mistakes and length of time it takes me to reconcile the orders I will have to ask the people that are going to help to please come in early for some training. There just isn't time to train during the ASC.

I checked with the printing company and was told the minimum order is 1000 copies. So I am recommending we go on as we are until the price increase which should be about April. You will notice some changes to the order form. There are some shaded areas and those are special order items (items we do not stock). The price we are charging right now reflects our cost plus the tax but it does not include the shipping charges. When we change the forms to reflect the new prices I would like to increase the items by an additional 7% to include the shipping and handling charges.

Treasurer's Report

Hi Everyone-

The Admin. Committee performed an audit on the Statement of Accounts during the December Admin. Meeting. There was a discrepancy with the November 8, 2007 deposit made at Tri-Counties Bank.

My records show that I deposited \$4037.99 into the account (the shaded areas of the Statement of Accounts). The banks records show that I deposited \$3957.93 into the account, which including a "bank error" of \$5.46. After the audit, it was realized that the \$80.06 discrepancy included all cash received from the November 7, 2007 Group Donations and the November 7, 2007 7th Tradition. I reconciled these numbers with the bank management, and they agreed that there is an \$80.06 discrepancy. The bank's assistant manager requested the bank video from the time of my deposit on November 8, 2007. As of January 6, 2008, the bank has not received the videos, which will show the actual deposit I made. To reconcile the account, I deposited \$80.06 from my personal account into the SacFNA account. If the problem is settled with the bank videos, I will return the \$80.06 to my personal account.

The Admin. Team of SacFNA discussed solutions to ensure accurate accounting of Area funds. The discussion Resulted in an overwhelmed collective conscience that we need to purchase an accounting software program to assist us in properly tracking funds. Since Quickbooks is the most common, I propose that we purchase a copy of Quickbooks Pro 2008.

Steve L., ARANA H&I Chair

Can split the county or do this together. Need more time to determine how the geographical boundaries shake out. ARANA jail coordinators don't want to split up the jails between Areas.

Did some research with other Areas (Washington didn't work well til the different Areas started working together). Split with Sierra Foothills was a different situation – different cities, area codes, etc. Bay Area thinks shared services don't work.

Need to develop guidelines before we split the subcommittee work. ARANA would like to have one subcommittee. Seems like folks with more clean time are more willing to change (and do shared services) than the younger members.

Q: Why are we splitting the subcommittee up?

A: Most of the facilities are in SACFNA area. Splitting the facilities up by geographical boundaries will ultimately abolish the ARANA H&I subcommittee.

Q: If we split the area, we'd get most of the facilities. There are tons of other facilities (recovery homes) that we could go to.

A: Tons of places want us there but we don't have the money for books, not enough bodies, or facility doesn't meet the criteria. If we split up, it will revamp the service structure of the subcommittee. It works well now. Splitting up will cause us to lose experienced mentors.

Q: Did your subcommittee get instruction from ARANA to figure out what is best?

A: They gave us six months. (H&I, PI and phonenumber)

Q: Just a thought to use the Coordinator Model, not have a chair, vice chair, etc.

Q: On an average what are your monthly expenses.

A: \$1400/month (rent, schedules, newsletters), about \$1250 of that goes to literature. Dropped our order to \$800. Can money donations paid for last month's literature order. Going to be reviewing our donations.

Q: If there was a split, would the coordinators who have those facilities stay with them?

A: Some coordinators may not be willing to come to SACFNA.

Q: What do other larger areas do?

A: Phoenix, has three areas. They meet together. One schedule for Phoenix, Scottsdale, Mesa.

Q: If we split up, will we loose our longstanding good relationships with these facilities?

A: Each facility is different. Some (like downtown jail) have longtime coordinator. RCCC and Folsom prison may have challenges.

Comment: One problem working with ARANA is we are reacting to their decisions. Six months seems like a good amount of time. But we will be waiting for ARANA to make decisions. We need to give input to the decision-making process, not just wait for this other body to tell us what will happen.
